

## RICE COUNTY QUARTERLY ACH PROPERTY TAX PAYMENT PLAN THE EASY WAY TO PAY YOUR TAXES

Rice County is pleased to offer you a direct ACH payment plan for your property taxes. Enrollment in this program allows you to have your property tax payment made automatically from your checking or savings account on a quarterly basis. You won't have to change your present banking relationship to take advantage of this service.

## How Can the Direct ACH Payment Plan Help You?

- Spreads your tax burden over four payments
- Saves time fewer checks to write
- Helps meet your commitment in a convenient and timely manner - even if you are out of town or on vacation
- No lost or misplaced statements
- Saves on postage costs
- No late charges

## Here's How the Direct ACH Payment Plan Works:

You authorize payments to be made from your checking or savings account according to the following schedule:

	Q1	Q2	Q3	Q4
Residential				October 15 <sup>th</sup>
Agricultural	March 31 <sup>st</sup>	May 15 <sup>th</sup>	August 15 <sup>th</sup>	November 15 <sup>th</sup>

Then just sit back and relax. Your payments will be made automatically. Proof of payment will appear with your bank statement.

Note: Delinquent taxes at time of enrollment will not pull. Contact the Property Tax & Elections Office for delinquent payment options.

Note: In the event you enroll in an ACH plan and subsequently make a payment via another method (i.e. check, credit card, online), a withdrawal from your account will still occur on the quarterly schedule noted above. The amount of the quarterly withdrawal will equal the remaining current year tax balance divided by the number of scheduled payments left for the year.

Note: You must notify the Property Tax & Elections Office and submit a new voided check or savings withdrawal slip when you change banks/accounts in order to continue this plan.

Q1 - March	1st Q2	- April 15th	Q3 - July 15th	Q4 - September 15th				
Forms received after these dates will be automatically enrolled for the next cycle.
