**Please Take Notice:** The Drainage Authority Joint Board of Commissioners of Le Sueur and Rice Counties, Minnesota, Drainage Authority for the redetermination of benefits of Le Sueur County Ditch (LCD) 54 will hold a final hearing on the Viewers' Report of Benefits and Damages for the redetermination of benefits for LCD 54. The Viewers' Report was filed with the Joint Drainage Authority on Oct. 31, 2019, and are available for inspection at the office of the Le Sueur County Auditor-Treasurer or the Rice County Auditor-Treasurer. The hearing will be held on January 15 at 2:30 p.m. at the Le Sueur County Justice Center, EOC Training Room (Lower Level), 435 E Derrynane St, Le Center, MN. The Drainage Authority will accept public comment regarding the Viewers' Report. Any party having an interest in the proceedings may appear and provide comment.
